Dear Author(s):

Thank you for submitting your Work for publication. In order to expedite the editing and publishing process and enable Frontline Medical Communications on behalf of the Society of Hospital Medicine to disseminate your Work to the fullest extent, we need to have this Copyright Transfer Agreement signed and returned as soon as possible. If the Work is not accepted for publication, or if the Work is subsequently rejected, this Agreement shall be null and void. Publication cannot proceed without a signed copy of this Agreement.

A. COPYRIGHT

1. The Author assigns to Frontline Medical Communications acting on behalf of the Society of Hospital Medicine of or renewals, all copyright in and to the Work, and all rights therein, including but not limited to the right to publish, republish, transmit, sell, distribute and otherwise use the Work in whole or in part in electronic and print editions of the Journal and in derivative works throughout the world, in all languages and in all media of expression now known or later developed, and to license or permit others to do so.

2. Reproduction, posting, transmission or other distribution or use of the final Work in whole or in part in any medium by the Author as permitted by this Agreement requires a citation to the Journal and an appropriate credit to Frontline Medical Communications as Publisher, and/or the Society of Hospital Medicine, suitable in form and content as follows: (Title of Article, Author, Journal Title and Volume/Issue, Copyright © [year], Society of Hospital Medicine). Links to the final article on the Journal’s website are encouraged where appropriate.

B. RETAINED RIGHTS

Notwithstanding the above, the Author or, if applicable, the Author’s Employer, retains all proprietary rights other than copyright, such as patent rights, in any process, procedure or article of manufacture described in the Work.

C. PERMITTED USES BY AUTHOR

1. **Final Published Version.** Frontline Medical Communications hereby licenses back to the Author the following rights with respect to the final published version of the Work:

- a. The personal right of the Author only to send or transmit individual copies of the final published version in any format to colleagues upon their specific requests provided no fee is charged, and further provided that there is no systematic distribution of the Work, e.g., posting on a listserv, website or automated delivery.
- b. Reuse in other publications. The right to reuse the final Work or parts thereof for any publication authored or edited by the Author (excluding journal articles) where such reused material constitutes less than half of the total material in such publication. In such case, any modifications should be accurately noted.
- c. Teaching duties. The right to include the Work in teaching or training duties at the Author’s institution/place of employment including in course packs, e-reserves, presentation at professional conferences, in-house training, or distance learning.
- d. Oral presentations. The right to make oral presentations based on the Work.

2. **Article Abstracts, Figures, Tables, Data Sets, Artwork and Selected Text (up to 250 words).**

- a. Authors may reuse unmodified abstracts for any non-commercial purpose. For online uses of the abstracts, Frontline Medical Communications encourages but does not require linking back to the final published versions.
- b. Authors may reuse figures, tables, data sets, artwork, and selected text up to 250 words from their Work, provided the following: that full and accurate credit must be given to the Work; modifications to the figures, tables and data are noted; the reuse may not be made for direct commercial purposes or for financial consideration to the Author.

D. WORKS OWNED BY EMPLOYER

1. If the Work was written by the Author in the course of the Author’s employment (as a “work-made-for-hire” in the course of employment), the Work is owned by the company/employer, which must sign this Agreement (in addition to the Author’s signature). In such case, the company/employer hereby assigns to Frontline Medical Communications, on behalf of the Society of Hospital Medicine, during the full term of copyright, all copyright in and to the work for the full term of copyright throughout the world as specified in paragraph A above.

2. In addition to the rights specified as retained in paragraph B above and the rights granted back to the Author pursuant to paragraph C above, Frontline Medical Communications hereby grants back, without charge, to such company/employer, its subsidiaries and divisions, the right to make copies of and distribute the final published Work internally in print format or electronically on the Company's internal network. Posting of the final published Work by the institution on a public access website may be done only with the written permission of Frontline Medical Communications and payment of any applicable fee(s). Also, upon payment of a reprint fee to Frontline Medical Communications, the institution may distribute print copies of the published Work externally.

E. GOVERNMENT CONTRACTS

In the case of a Work prepared under U.S. Government contract or grant, the U.S. Government may reproduce, without charge, all or portions of the Work and may authorize others to do so, for official U.S. Government purposes only, if the U.S. Government contract or grant so requires.

F. COPYRIGHT NOTICE

The Author agrees that any and all copies of the final published version of the Work or any part thereof distributed or posted by them in print or electronic format as permitted herein will include the notice of copyright as stipulated in the Journal and a full citation to the Journal as published by Frontline Medical Communications.

G. AUTHOR'S REPRESENTATIONS

The Author represents that the Work is the Author's original work, all individuals identified as Authors actually contributed to the Work, and all individuals who contributed are included. If the Work was prepared jointly, the Author agrees to inform the Coauthors of the terms of this Agreement and to obtain their signatures to this Agreement or their written permission to sign on their behalf. The Work is submitted only to this Journal and has not been published before. (If excerpts from copyrighted works owned by third parties are included, the Author will obtain written permission from the copyright owners for all uses as set forth in the Journal's Instructions for Authors and show credit to the sources in the Work.) The Author also warrants that the Work contains no libelous or unlawful statements, does not infringe upon the rights (including without limitation the copyright, patent or trademark rights) or the privacy of others, or contain material or instructions that might cause harm or injury.

U.S. Government work

Note to U.S. Government Employees

A Work prepared by a U.S. federal government employee as part of the employee's official duties, or which is an official U.S. Government publication, is called a "U.S. Government work," and is in the public domain in the United States. Note to NIH Grantees
